



### Report of the Senior Warden Obie Pinckney

### "EMBRACING OUR FUTURE: 2019 & BEYOND"

- **1.** Purposes of the 2019 Annual Meeting:
  - a. To give an annual accounting of the ministries and services of the church;
  - b. To highlight the opportunities and challenges of what we face in finding and selecting the Rector that God has ordained for us.
- 2. The Episcopal Church of the Atonement, like the majority of mainline churches in the country is declining in membership and getting older per capita for various reasons that have been researched.
- **3.** What is our perspective in trying to find solutions to this challenge?
- **4.** In 2012, we formed a Strategic Planning Committee to find solutions to ensure that the "Atonement wing" of the Body of Christ would be guided to the needed solutions by being led by the Holy Spirit in the development of a Five Year Strategic Plan for our parish.
- 5. Through participation in a comprehensive survey by a majority of the members of the parish and focus group sessions by the church ministries and organizations, we agreed on seven core values that we believe are central to our being able to functions in accordance with God's plan for our parish and the strengths and weaknesses of the church were determined.
- **6.** Goals were agreed upon for each core value and objectives were defined to achieve each goal. Organization and resources needed were delineated and a strategic plan was developed through much praying and interaction with God.
- 7. The end of the year reports from the Vestry Committees will provide you with a more comprehensive description of progress in implementing the strategic plan. Following is an abbreviated statement of the status of our work with regard to each core value:
  - Worship and Music: Considerable progress has been achieved in restoring the senior choir to its glory days under the able leadership of Dr. Michael Clarke and the influx of new voices. The meaningful involvement of youth in the music of the parish is in the plan. The Rector chairs this important vestry committee. The incoming Rector will become the chair and guide our continued growth and effectiveness in music and worship to attract new worshippers.
  - Christian Education, Growth and Development: This is one of the three core values designated by the Vestry as priorities, community outreach and finance being the other two. Dr. Paula Boone has assumed leadership of the vestry's Christian Education Committee and is making a determined effort to recruit volunteer teachers and administrative support staff. A strategy for successfully recruiting young families and for the establishment of a diversity of interest areas and activities is needed.

- Pastoral Care: The Rector is the Chair of this core value committee and that position is now vacant. Fortunately three Lay Eucharistic Minister/Visitors, Douglass Bowman, Cora Floyd, and Obie Pinckney, all assisted the previous Rector and are continuing to follow the visitation schedule until the new Rector is onboard. There is a committee of trained lay visitors who visit sick and shut-in members of the organizations to which the lay visitors belong.
- **Fellowship and Hospitality:** This is a strong area because of the dependable work of the Welcoming Committee which is enthusiastically led by Cora Floyd. Kelly Marie Berry is the Chair of Vestry committee and keeps the Vestry informed of fellowship activities by providing a monthly status report of activities sponsored by church ministries and organizations. There is strong strategic planning and congregational emphasis on fellowship and outreach within the parish.
- Community Outreach: Rochelle Harley, Chair of this core value committee, is leading an active and determined effort to collaborate with community civic groups and service providers as well as schools, other churches, and government agencies to establish our parish as an effective community partner in Ward 7. Read her full report and offer your suggestions as to things the church organizations can do to realize our goals of (1) providing assistance to families in need, and (2) increasing our membership from the community families through effective outreach.
- Stewardship and Fundraising: Although our Stewardship Chair Robert Smith and Fundraising Chair Rochelle Harley are actively promoting the goals and objectives of their respective Vestry committees, our short-term and long-term goals for additional resources. The need for generous giving from our faithful membership to meet the operational needs of the church and our dependence on fundraising efforts to meet unpredictable calls for help will grow in the future. Thank you all for your Christ-like generosity. It is needed and appreciated.
- Governance and Administration: The productive work and energy of Parish Administrator Anita Marsh and the knowledge and skill of our Technology Committee Chair, Dr. William Neal, has helped increase the productivity and efficiency of the business office and finance office operations significantly. Improvements in automation will continue into 2019. Senior Warden Obie Pinckney chairs this core value committee. Sub-committees include: Finance-Karen Neal; Audit-Robert Smith; Investments, Legal Counsel-Eric Pookrum, Esq.; Counting Teams-Clorine Lafargue; Church Security-Darrin Dorsett; Property Maintenance-Junior Warden David Warr.

Please read the entire Annual Report and the reports from the various parish ministries, organizations, and committees. If you see areas of need where your experience and skills could be helpful, please contact the appropriate parish representative. If you don't know who that individual is, contact Anita Marsh, Parish Administrator, a Vestry member, or me.

### Junior Warden Annual Report for 2018 01/14/2019

2018 has been a challenging year for Atonement. The year ended in the midst of a transitional period for the church. After losing our rector of twelve years, Atonement has had to continue to sustain church operations, including maintaining facilities, as we search for a new leader of the flock. The Holy Spirit has truly blessed our church and its leadership during these trying times.

Church facilities and property maintenance of the past year have been very successful, considering the many activities and events we had to accommodate throughout 2018. The church suffered a few repairs during the year, mainly roof leakage from the record rains we experienced throughout the year. The boiler system performed well with only the necessary yearly maintenance required. Due to our new esteemed choir director who brings a new energy to our choir, many upgrades to the organ and piano have been done. Major upgrades in Hi-Tech technology including WiFi and a meeting room monitor. Security camera Ring technology was also added to improve overall security.

The church property located at 78 53<sup>rd</sup> Place SE is being prepared for a new tenant, since the former lease expired the end of June 2018. Since Atonement was blessed with the Samuel's property located at 41 54<sup>th</sup> Street SE, we're planning to begin renovations 1<sup>st</sup> quarter 2019.

This report is a brief summary of some of the highlights from year 2018. The Junior Warden is committed to the Core Values expressed in Atonement's Five Year Strategic Plan. If you, as members of Atonement have any projects, ideas, or suggestions concerning the future of Atonement facilities, please bring them to the Junior Warden. We need your eyes and ears to help us continue to keep our Church of Atonement in the forefront.

### **Personal Observations**

**Delegate**:

On Saturday, January 26, 2019, I had my first experience as a Convention Delegate for the Atonement Parish. I was very impressed by the Guest Preacher, Nancy Beach — Willow Creek Community's Church's first female teaching pastor. Here are my reflections from her interactive speech.

Rev. Beach spoke about "Building Teams That Last" and the eight signs of a healthy church culture: joy, healthy, self-awareness, humility, vulnerability, credibility, commitment, and love. Who will you (your church and you) be? While she presented, we rated ourselves on the signs.

Rev. Beach spoke about churches with pastors who have inserted themselves in a spiritual category that doesn't exist. They think they are someone they're not and respond in ways they shouldn't creating habits that are spiritually dangerous. These pastors may then become content with a devotional life that either doesn't exist or is constantly kidnapped by preparation. She told us that it's important that we don't think so highly of ourselves, but rather to think of ourselves with sober judgment. (Romans 12:3)

Referencing *Dangerous Calling* by Paul David Tripp she talked to us about trust and how hard it is to trust others when they are too self-assured, too self-aware, domineering, speak more than listen, quick to criticize and not receive criticism, and have assigned themselves with way too much glory. If church becomes the one page in society where women and men cannot serve together as equal cobearers of the image of God, it will increasingly damage the credibility of the gospel. (John Ortberg)

Ministry is a series of difficult conversations. Let me give you a new command: Love one another. In the same way I loved you, you love one another. This is how everyone will recognize that you are my disciples — when they see the love you have for each other. (John 13:34, 35 MSG)

### **The Proceedings**

- 1. The Dean of the Washington National Cathedral spoke and presented a list of resources and privileges that the Cathedral is granting to the Washington Diocese and local parish members.
- 2. Newly Ordained Deacons, Newly Ordained Priests, and Clergy in New Ministries were presented.
- 3. Bishop Marianne Budde addressed the Convention and spoke of the need to find better ways of re-energizing the church. She referenced the "Jesus Movement" focus of Presiding Bishop Michael Curry. She spoke about the diminishing attendance in the church and the need to apply promotional approaches to implementing the Gospel of Jesus. She announced the initiation of the development process for a Strategic Plan for EDOW. The Unstuck Church Consulting Group is under contract to assist the diocese and parishes to develop a diocesan strategic plan and she is praying that each parish will develop its own strategic plan as a part of this effort. She is asking each parish to send two volunteer members to serve on the Regional Leadership Team for the region in which the parish is located.
- 4. A \$4,255, 293.00 budget was approved for 2019.
- 5. Clerical and Lay members of Standing Committees were elected
- 6. Several resolutions were approved, including one supporting continuing collaboration with the United Methodist Church toward a goal of full communion between the Episcopal Church and the United Methodist Church.


### **Annual Report Form for Calendar Year 2018**

**Atonement Young Adult Employment Ministry (AYAEM)**

### My Fellow Atonement Parishioners:

As 2018 ends, we remember the tremendous accomplishments made by AYAEM. Staying true to our Mission, AYAEM successfully recruited, screened, trained, certified and mentored thirty-four (34) participants and graduated thirty (30). 2019 Program Board modification incorporated a Computer Literacy Session & extensive retention services and outreach. Job Readiness Training Sessions were suspended pending grant funding.



Three (3) grant applications were submitted in support of our Job Readiness Program to the following:

- 1) The Morris & Gwendolyn Caftritz Foundation
- 2) The Eugene & Agnes Meyer Foundation
- 3) The Baker Donelson Community Grant 2018

Although we have not been successfully funded by these efforts, the ground work and outreach effort has been established. The most prevalent preventive factor is that AYAEM is unable to maximize efforts based on our Session 1, 2 & 3 graduate results to maintain employment. Compelling success rates and retention factors are present for those anticipating limited employment due to existing or documented disability. AYAEM graduates seeking full-time employment are dismayed with involuntarily reduced work hours from new management transitions as a factor beyond AYAEMs control. Our retention component will be reestablished as new collaborative relationships with various area businesses as potential employment opportunities. We appreciate any information or suggestions of applicable grant opportunities.

Our CACPN (Creative Arts Community Prevention Network) partnership with JC Nalle Community School and NCCF (National Center for Children & Families) has provided an opportunity to secure future GED Program opportunities for future AYAEM graduates, Atonement parishioners and their families, and community partners and a sincere interest to recommend parents of JC Nalle students to participate in our Job Training Sessions once reinstated. This is an optimized asset to AYAEM in that maximum output with no cost.

Our AYAEM marketing brochure was included in the give-away gift bags for the successfully collaborated Atonement Community Health Awareness Day; highlighted during a Parent Forum held @ JC Nalle for their parents; spotlighted in NCCFs piloted You Tube Video of the Community Health Event and currently available for viewing on our website. Additionally,

AYAEM has successfully marketed our mission with community partners and established an environment for future engagements.

The Crab Feast was selected as a major fundraising effort for AYAEM and was held Friday, July 13, 2018. AYAEM established a formidable partnering relationship with Rev. Prince and their Vestry @Epiphany Episcopal Church in Forestville, Maryland, in agreement to support our Crab Feast and waive rental fees in the amount of \$1200. AYAEM Board members proactively and financially supported this effort to reduce costs with donations of food, supplies and especially ticket sales. Overall, the Crab Feast provided vital operational support for the remaining calendar months.

The AYAEM Mission is rooted in mentoring. Our mentoring network has yet to establish a sustained and diverse pool of enthusiastic and engaged mentors whether parishioners or community partners or stream of volunteer-mentor pathways. Existing AYAEM Committee volunteers & Board members have been tasked with multiple roles in addition to serving as mentors. Goals to establish a focus group providing mentoring resources, prospective mentor candidates and growth options is vital to our mission. AYAEM Volunteers are essential to the growth of our organization. We are small but mighty. There is a place at the AYAEM table and an opportunity to share your talents. Please join us!

Select AYAEM Board members, under the direction of Marie Queen, compiled an extensive Resource Manual indicating Drug Rehabilitation & Treatment Centers, Narcotics & Alcoholics Anonymous Meeting Listings, and Expungement Process Locations for the Washington, Maryland and Virginia. Although originally intended AYAEM candidates, graduates and their families, but also an available Atonement resource in downloadable format to new and struggling parishioners.

Targeted AYAEM goals include reorganization of our mission and branding; target audience; extensive recruitment of prospective employers; building on emerging partnerships with community stakeholders; and the adaptation of community partner resources and funding in alignment with our revised mission.

It is important to note that ECW is not allowed to collect membership dues from members. ECW has donated over \$1700 to the Food Pantry over the past 2 years by sponsoring 2 trips to the Toby's Dinner Theater located in Columbia, Md.

Also, we are pleased to report an addition of three (3) new members.

**Church Ministry/Organization/Committee**: Food Pantry **Chair/President:** Patricia Marshall

**2018** was a great year for the Atonement Food Pantry. In our second full year of service, we provided over 29,000lbs. of food to those seeking emergency food assistance in our surrounding community. As in 2017, the food we distributed included meats, some dairy items, nonperishables, and farm fresh produce. Contributions from parishioners have continued to be robust and help us to better manage expenses. On average, we served 75 individuals and their families monthly. If you add the family members of our registered shoppers, we served well over 100 people monthly.

Our budget was \$10,000 in 2018.

Hunger or food insufficiency is not to be viewed in a vacuum. Many of our shopping guests are not just hungry, and in 2018, we continued to offer gently used clothing and books. With the support of the St. Helene's Guild, we now offer toiletries. Our cooperation with the Atonement Young Adult Employment Ministry ("AYAEM") continued as a number of our food pantry guests participated in AYAEM sessions, securing employment opportunities in the end. In the summer of 2018, the food pantry took to the road, setting up produce tables at the Atonement Community Health Awareness Day held at JC Nalle Elementary School.

While we had much to celebrate in 2018, we still have a few challenges to overcome. First, we received a 72% Wellness Score for the Partners for Wellness Program through the Capital Area Food Bank, which is less than our Wellness Score in 2017. We need a 75% or higher Wellness Score on our purchases to be considered A Partner For Wellness, which would afford us grant money, a new refrigerator or freezer, and other partner benefits. A 72% score means we need to improve our food offerings to include more nutritious foods – less sodium, less added sugars, and more fresh produce. We need to STEP UP OUR WELLNESS GAME ATONEMENT! Second, we had no technology to make our registration process more secure and efficient. Our guests are consistent from month-to-month, so it is imperative that we become more efficient with our registration process. Technology will help move us along in 2019.

Despite our successes and challenges, 2019 offers more opportunities to expand the food pantry ministry. We will begin to offer food demonstrations, so to assist our guests in learning how to prepare nutritious dishes from our more unique pantry offerings.



My Fellow Atonement Parishioners:

God has truly Blessed Atonement! 2018, in review, boosts opportunities that could be considered beyond our "typical normal." Multiple Atonement fundraising efforts such as Do More 24 and the Atonement Community Health Awareness Day was an extensive volunteer request that Atonement Parish answered. Engagement of existing Atonement parishioners who have embraced intensified Atonement efforts toward achievement of our Strategic Plan goals for community engagement and economic growth in our Ward 7.

AYAEM/Atonement successfully participated in the Do More 24 Online Campaign for the second year. We exceeded our 2017 Goal by raising over \$4500. Our 2018 efforts surpassed our expectations as well. We received the "Night Owl Award" in the amount of \$1000 for amassing more online donations during the 12am until 5am campaign time with 472 eligible non-profits serving the Washington Metropolitan Area. Overall, our 2018 Do More 24 efforts totaled over \$5000 due to the online campaign and an Atonement Member Donation Campaign. Our success was acknowledged and subsequently United Way has requested that AYAEM submit a campaign bio for incorporation into future marketing materials. Well done, Atonement!



We were fortunate to network with a partnering non-profit organization during the Do More 24 Awards Event held May 30, 2018. Christian Legal Aid of DC non-profit was the top award winner in the nonprofit category for revenue less than (1) one million dollars, as were we. This partnering opportunity allows Atonement Parish and AYAEM to refer eligible DC residents needing legal resources and representation regarding expungement, housing and employment services, and civil matters. Many graduates of AYAEM would directly benefit from these services as well as their families. Most especially, Atonement is considering formally applying to provide a future location for Legal Clinics.

An inaugural AYAEM Crab Feast was held Friday, July 20, 2018, at Epiphany Canterbury Hall located in Forestville, Maryland. The Diocese encourages establishing partnerships with diocesan parishes for future grant opportunities such as Epiphany Episcopal Church. This Diocesan Partnership supported the AYAEM Mission and Atonement to provide facility space use on a gratuitous basis for future endeavors.

Atonement's opportunity for collaborative partnership with the CACPN Network sets the groundwork for continuing partnerships with JC Nalle Community School, NCCF – National Center for Children and Families, DBH – Department of Behavioral Health, DOH - Department of Health, AAMA – African American Music Association, George Washington Medical Center, Lombardi Cancer Research Center, Howard University Hospital, Wegman's, DC - Department of Health, Washington Nationals, Marshall Heights Civic Association and CVS to name a few.

The Atonement Community Health Awareness Day held at JC Nalle ES (219 50<sup>th</sup> Street, SE) on Saturday, October 13, 2018 between 9am – 2pm was an absolute success in fostering community engagement between Atonement and our Ward 7 neighbors. We anticipated 250 participants and preliminary stats indicate that approximately 175 persons attended our event. Atonement participation was tremendous! I can confidently state that every organization was well represented in the overall effort for this event such as in food preparation, registration, logistics, stuffing of event bags and literature, transportation, event day support, and clean-up. An extreme sense of fellowship was refreshing to witness amongst parishioners and was evident by the number of volunteers willing to do whatever was necessary to get the job done.

Our CACPN Network Partnership also provided a collaborative opportunity to facilitate a Parent Forum with parents of JC Nalle Community School students in partnership with NCCF on 11/17/18. Dr. Orlando Barker, DBH (CACPN Network Partner), provided a detailed Opioid Awareness session for parents; Atonement engaged them with an Opioid Awareness Jeopardy Game; and we issued \$25 gift cards to the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place participates. Our Community Outreach efforts are established to continue this venture at our Parish venue at a future date. Atonement had already established a relationship with this cohort of parents during our Atonement Community Health Awareness Day in October.

The Atonement Parish and Ward 7 community mutually benefited from this emerging partnership. Our Parish & AYAEM flyer/brochure was included in the give-away gift bags highlighting our various organizations, Food Pantry Ministry, worship time and most importantly, website and contact information; highlighted in a NCCF piloted You Tube Video from the Community Health Event available on our website; created an emerging partnering opportunity to provide GED Training to AYAEM graduates & families and market AYAEMs Job Training Program to JC Nalle parents. This outreach gives prospective Rector candidates an enhanced snapshot of our Parish Life. Additionally, we have successfully marketed our mission with community partners and established an environment for future engagements.

Consequently, NCCF solicited Atonement to host and financially support its inaugural Mother-Son, Father-Daughter Holiday Ball on 12/13/18. Atonement decorated our Parish Hall; supported and provided a delectable meal for our guests; chaperoned this event; and generally joined our 116 guests comprised of students, their parents, NCCF Staff and Atonement Parish volunteers and AYAEM Board members and volunteers on the dance floor. Fun was had by all as indicated in pictures on our website of party dresses & curls, dapper young men with fresh cuts, and family photos. This venture was in direct alignment with the Atonement Strategic Plan

by introducing our spiritually based church home and inviting our Ward 7 community to worship with us. Atonement is eagerly growing its membership. Once again, our Atonement Parish rose to the occasion and provided a warm welcome.

We embrace and celebrate emerging partnerships with political and community stakeholders. Attending ANC – 7E meetings as Atonement's Community Outreach Director on the second Tuesday of each month at the DC Scholar's Charter School on East Capitol Street has forged emerging partnerships with ANC Commissioners; marketed our Atonement Community Health Awareness Day; and reestablished Atonement Episcopal Church's presence. Atonement has established its footprint by facilitating an engaging and successful Community Health Awareness Event for Ward 7. More importantly, the mission of AYAEM was prominently marketed with staff managers from Mayor Bowser's Office & Council Member Vincent Gray's Office. We are also on a first name basis with MPD Commander and speed dial with Officer Medina who provided security support when requested for our Awareness Day and Mother-Son, Father-Daughter Holiday Ball. This connection must be fostered and maintained.

The raffle drawing for 2 tickets to the 2019 Washington Nationals season will occur on Sunday, January 27, 2019 during Announcements. \$5 raffle tickets are still available.

Atonement, there is still work to be done and Ward 7 community members to embrace into the Atonement Episcopal Church fold. I pray that we continue to be Blessed and empowered toward God's mission. Thank you for your continued support and opportunity to "Touch the Hem of His Garment!"

The Youth Christian Education program experienced several internal changes this year. They began with the elimination of paid staff to organize and coordinate the youth program due to budget constraints. This was followed by cancelling Vacation Bible School due to lack of adult volunteers and support staff.

In an effort to revive Youth Christian Education, volunteers were recruited and the time for Sunday class changed to coincide with the start of Sunday service at 10:00 a.m. There are two faithful teachers each Sunday, a seasoned one paired with a new volunteer. These changes allow teachers to commit to only one Sunday a month and participate in their other church responsibilities on the other 3 Sundays. Teachers and students come down for communion. At this time students are reunited with their parents in the congregation.

Volunteers have done an exceptional job of having lessons and activities prepared but attendance is low.

The Praise Dance Ministry was formed to introduce a new form of worshiping God at Atonement. While the ministry hopefully will bring new members to the church, the ministry also is to build a relationship with the youth and other members of the ministry. We believe "dance" was ordained by God as one of the many methods of ushering in the Holy Spirit and winning souls for Christ.

#### **Celebrant:**


Will you faithfully and reverently execute your duties to the honor of God and the benefit of the members of this congregation.




#### **Celebrant:**
